



**University Student Ambassador National Programme**  
**on Child Protection**  
**National Child Protection Authority (NCPA)**

The “University Student Ambassador National Programme” (USANP) on Child Protection is a unique programme organized by National Child Protection Authority (NCPA) with the purpose of developing knowledge, skills & attitudes of university students on child protection. Internal students those who are in 2<sup>nd</sup> & 3<sup>rd</sup> year at any university approved by University Grant Commission (UGC) are eligible to register for this volunteer programme. It is expected to implement this programme as a sustainable programme which aims at develop knowledge on child protection among university students & create a graduate who is having thorough knowledge in child protection during the process of socialization. National Child Protection Authority will implement this programme in collaboration with University Grant Commission (UGC) & Universities.

The knowledge, skills & attitudes that University Student Ambassadors gather at young age will contribute to create a leader in child protection who prioritize child protection, stand against child abuse, take necessary actions in every possible occasion that needs to protect children, develop concepts and creative initiatives which affirm child protection as adults or professionals work in diverse sectors. It will enable the skill to understand the current context of Child Protection in Sri Lanka.

This programme will create a platform to share global level experience with foreign university students in future. Specially, It is important for young university undergraduates to focus on child protection. University Ambassadors will be accountable to implement United Nations Convention on Right of the Child (UNCRC) & to achieve Sustainable Development Goals (SDGs). Further, as the young generation of the country will get an opportunities to protect the children of this country through this programme.

### **Main Objectives**

1. To create a youth community who are responsible & accountable on child protection.
2. To create awareness about National Policy on Child Protection among university Students.
3. To develop knowledge, skills & attitudes on child protection to create a child friendly and protective environment for children.
4. To get suggestions & participation of university students in order to minimize & prevent child abuses.
5. To get the participation of university students in the process of decision making in child protection.
6. To get contribution to draft policies in child protection & to advise government by obtaining suggestions from the university students.
7. To provide opportunities of networking with NCPA officers.

### **Registration Procedure**

Only the 2<sup>nd</sup> & 3<sup>rd</sup> year internal students of any university approved by University Grant Commission of Sri Lanka, who wish to participate to the University Student Ambassador Programme can register for this volunteer programme. Application can be downloaded from Official website of National Child Protection Authority [childprotection.gov.lk](http://childprotection.gov.lk). National Child Protection Authority will issue a registration number for every undergraduate & a letter to confirm the registration

## **University Ambassador Programme will conduct in five stages**

**Step 01:** One day programme for conducting awareness programme for undergraduates registered for “University Student Ambassador National Programme on Child Protection”

**Step 02 :** The undergraduates registered for University Ambassador National Programme on child protection will be able to work 1-3 years with National Child Protection Authority. They will get an opportunity to work with a Student Ambassador School. Under this programme a team of university students will be nominated for every school registered for Student Ambassador National Programme. Accordingly University undergraduates will get an opportunity to do individual & team activities. These activities should be implemented by the university students under complete supervision, guidance, technical know-how, coordination & operation of National Child Protection Authority.

**Step 03:** Two day Programme on Child Protection

### 03.1 – First Day

1. Introducing on child rights, child protection, national policy on child protection, what is National Child Protection Authority, its functions & programs.
2. Knowledge sharing on the ethics those university undergraduates should adhere in child protection.
3. Train how to obtain child participation, communicate with children & sharing knowledge in maintaining public relations with children.

### 03.2 - Second Day

1. Laws related to children & role of law enforcement of National Child Protection Authority.
2. Psychosocial intervention related to children
3. Obtaining feedback & suggestions from the university students

**Step 04:** Develop student resource pools on child protection at university levels & develop national level university student resource pool on child protection.

**Step 05:** “University Student Ambassador National Summit” for experience sharing.
